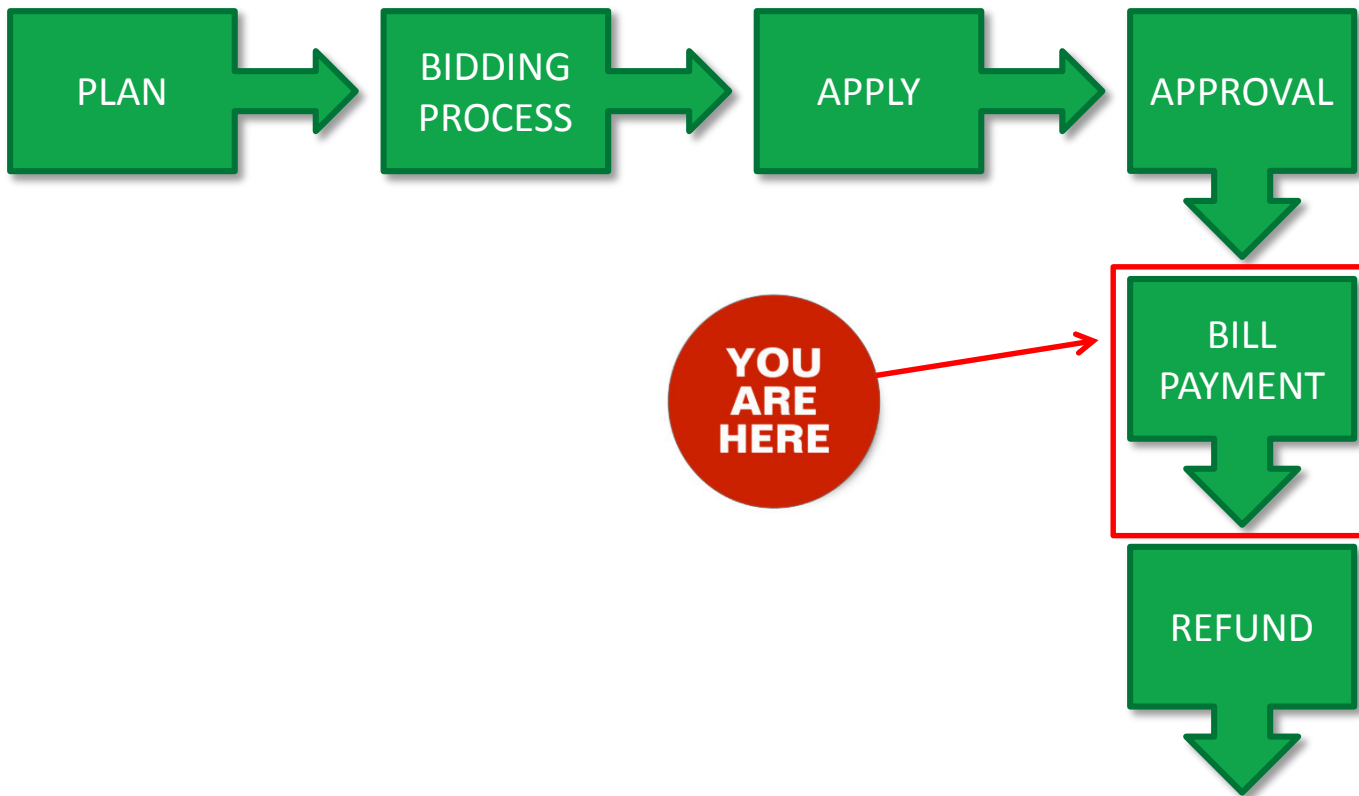

The Basics

What is the FCC Form 486?

An indication that services for a particular Funding Request Number (FRN) have started

- Notifies USAC that services have started and that invoices for the E-Rate discount portion of those services can be processed and paid
- Reports the status of the applicant's compliance with the Children's Internet Protection Act (CIPA)

When can I file a Form 486?

- The Form 486 cannot be filed until a Funding Commitment Decision Letter (FCDL) has been received.
- However, the Form 486 must be certified no later than 120 days after the service start date *or* 120 days after the date of the FCDL, whichever is later.

Words of Caution: Filing late can result in a reduction in funding. The later the filing date, the greater the reduction.

Where do I file a Form 486?

You must file the Form 486 by accessing the account in the EPC Portal for the Billed Entity that received the funding commitment.

This is usually the school district, unless an entity is considered to be an independent school.

How many separate forms do I file?

Your choice!

Each FRN from your Form 471(s) is treated separately and you will need to indicate the start of services for each one.

- You may file a separate Form 486 for each FRN as you receive funding commitments



- You may include several funded FRNs on a single Form 486

Words of Caution: Be aware that the Form 486 for each FRN has a distinct deadline!
Don't miss a deadline while waiting for all of your funding commitments to come in.

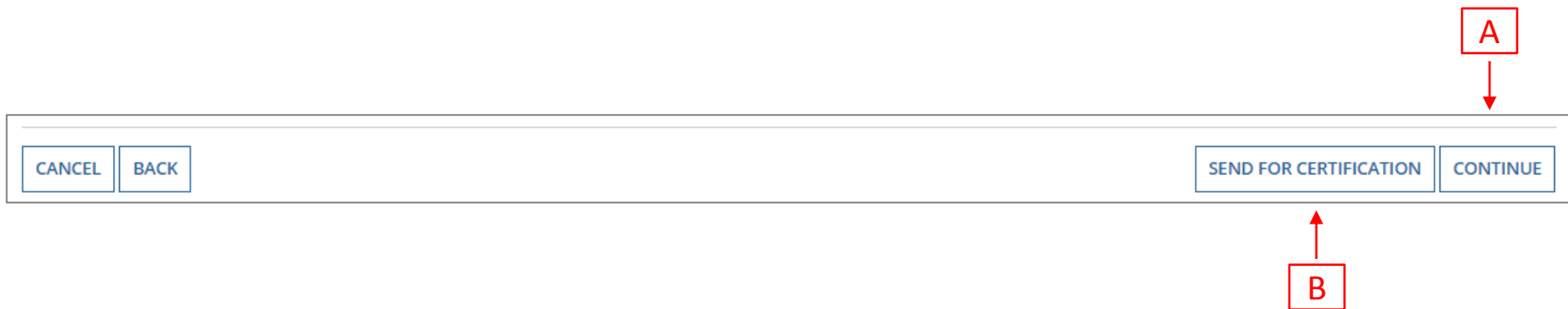


